I. CALL TO ORDER- 9:00 AM in Orchard Creek Multi-Purpose Room.

- e) Christmas Party/Breakfast: Discussion as to future location, possible door prizes rather than bringing gifts for give away. Brad will convene a group to discuss further.
- f) Club Flyer: Debra passed around another draft; received final comments/suggestions.
- g) Videography Group Merger: Phil (Videography grp. treasurer) gave check to Dale for the 14 members that were not already LHPC members. Jeff to work with Bob to establish a section on the website and with Kate McCarthy (Video grp) for input. Jeff will work with Diane Margetts on Compass/Sun Senior News communications. The Video SIG will concentrate on sharing and editing. Jeff also shared the concern of CCOC with no. of SIGs and how much space/rooms they require.
